INTRODUCTION

The NCMG Peace Awards recognize and honour individuals and organizations that continually make exemplary commitment and contribution to the pursuit of peace, judicial innovation, corporate citizenship and youth innovation while championing the capacity of humanity to live in harmonious adjustment with one another. The NCMG Peace Awards is categorised as follows:

- ➤ PEACE BUILDER: The Peace Builder category recognises an individual, organisation, or institution that develops initiatives that contribute to positive social change, facilitate the establishment of peace, and assist in preventing the recurrence of violence by championing the interventions designed to promote peaceful co-existence and harmony.
- > **JUSTICE BUILDER:** This Award category distinguishes an individual, organization or institution who demonstrates that access to justice should offer a variety of approaches and options for dispute resolution within the judicial system.
- > OUTSTANDING WOMAN OF PEACE: The outstanding woman of peace category is targetted at any woman or organization of women that initiates projects, programs and activities for the attainment of sustainable peace.
- ➤ YOUTH INNOVATION: Limited to those under 35, this category recognizes and honours an individual, association, institution or organization that mobilizes Nigeria's youth to act as community leaders in conflict management and reconciliation through the promotion of dialogue.
- ➤ CORPORATE CITIZEN: This Award recognizes a corporation that constructively engages community stakeholders in peace building initiatives by making significant contributions to the standard of living and quality of life of the residents of the community within which they operate.
